



VOLUNTEER AGREEMENT

In accepting this volunteer position with SACT, it is my understanding that it is my responsibility to attend each necessary function associated with performance and will contact one of the Directors (or Assistant Director) in the case of illness or emergency. Absences are not tolerated unless cleared in advance with the proper party. Additionally, it is my responsibility to follow procedures and guidelines of SACT at all times during activities on premises. Failure to comply can result in dismissal from the facilities or other further actions as necessary by SACT Board of Directors.

Release of Liability and indemnification

I, as either the participant and/or the parent(s) and/or legal guardian(s) of said Participant agree that in the event that the Participant suffers an illness, injury(ies) while participating in any SACT sponsored production or event, the parent(s), legal guardian(s) and/or Participant shall be solely and fully responsible for any and all medical or injury-related treatment and/or expenses. By signing below I, either for myself as a Participant and/or as the parent(s) and/or legal guardian(s) of the Participant hereby agree to defend indemnify and hold harmless SACT and/or its assignees, its officers, board of directors, agents, volunteers, staff including contractors, subcontractors and/or their assignees from any and all claims, actions, expenses, costs, obligations, liabilities and/or damages (or any other element of damages), known or unknown, resulting from or arising out of the rendering of any and all first aid, if any, and/or resulting from any illness, injury(ies) and/or death of the Participant occurring at any time during and/or related to the participation in any SACT sponsored production or event.

Workers Compensation

You are hereby advised that SACT does NOT carry Workmen's Compensation Insurance. If you or your child/children should suffer an injury while participating in a SACT production you will be personally responsible for your medical or injury related expenses.

Further Limitation of Liability and/or Damages

SACT is not responsible for any reason for any act, error or omission (whether said act, error or omission is intentional, negligent and/or for reasons beyond the control of SACT) of the SACT and/or its assignees, its officers, board of directors, agents, invitees, volunteers, staff, independent contractors, technical crews, subcontractors and/or their assignees and which result in damages, costs, and/or expense to and/or on behalf of the Participant and/or the Participant's parent(s) and/or legal guardian(s).

Lost/Stolen Property

SACT is not responsible for any lost or stolen items of personal property of the Participant while said property is at an SACT sponsored production or event.

Indemnification Agreement

I hereby agree to release, defend, indemnify and hold harmless SACT, its officers, directors, producers, staff, volunteers, agents, invitees, contractors from any and all liability arising from or related to, my child's/children's or my participating in activities associated with theatrical productions.

Damages

SACT strives to offer a safe and clean environment for positive theatrical productions. If by, negligent or purposeful intent, the participant or responsible parties for the participant cause harm or damage to any member of SACT staff or volunteers at any point in the participation in association with performances and activities on premises the person or people responsible may be held liable for any costs incurred to replace, repair, treat or otherwise put into working order those elements damaged or harmed.

The accident waiver and release of liability shall be construed broadly to offer a release and waiver to the maximum extent permissible under applicable law.
